In March this year I contacted the store to check the prices and the availability of a gun I wanted to buy for my husband's birthday in April. I called 3 different times and got a recording saying they were busy trying later. Then I left an email asking for the gun... There is no response. Finally, I went to the store where I had five people in front of me. There was no one waiting for the customers. There was a woman and a small child behind the counter and I once looked in the back room where I assumed the owner was, but no one said someone would be with you soon or thank you for your work. After waiting 15 minutes, the first man in line left. I waited another 5 or 10 minutes before I left and still one person checked on the customers. While waiting I was also put off by signs that were rude borders, (i.e. no muddy shoes). I will never buy a gun or other accessory in that store I will go to the streets in Morgantown where they have real customer service!IconBusiness Response03/06/2019 I am sorry for your experience and thank you for your input. I am the first to admit that we have been experiencing increasing pain over the past year, yet we are working hard to improve this. If you stop now, for example, you'll notice that we've recently hired two additional employees, and at the same time, keep prices well below the prices our competitor mentioned. However, we are committed to giving as much attention as possible to each customer, which means that if there are customers in front of you, you may have to wait a little longer. This is a highly specialized industry and choice, ordering and buying a gun is more time-consuming than most other retail purchases. This is also one of the most highly regulated commercial industries, and if we #39 re-in the back, I can assure you that we #39 not try to ignore you, we most likely run background checks and prepare or complete the required paperwork on other customers. In respect for the privacy of our customers, unlike many of our competitors, we do not #39 conduct this process on the sales floor where other people can see your papers. As far as our signs go, in maintaining a clean, professional, and safe environment, there are some behaviors that we prefer intolerance. For example, having spent more than \$4,000 on flooring, I would prefer that people don't #39 come in, knowingly tracking mud and grease around my flooring, so from I have a sign! It would be different if we were to buy agricultural equipment or tractor parts. If I'm paying to clean my floor professionally, this will lead to higher prices on the goods. Once again, I sincerely apologize for your experience and hope that I have addressed your concerns. I do not welcome you again and will be happy to help you personally if you do! While other firearms retailers have come and gone in the scene in the past few years, we have continued to grow. In fact, our sales figures (total revenue and number of firearms sold) are on track to surpass each of the previous two years.
